

**INSTITUTE OF CHRIST THE KING SOVEREIGN PRIEST
CODE OF CONDUCT REPORT FORM - WISCONSIN**

Wisconsin law asks ALL individuals and REQUIRES Mandatory Reporters who have reasonable cause to suspect that a child has been abused or neglected or threatened with abuse or neglect to report that suspected abuse or threat. Reporting is done by making a telephone call to the local police, the county sheriff, or the county child protective services agency. Furthermore, your diocese should be told if a report has been made to civil authorities, and they also request reports of any violations of the Diocesan safe environment policies or code of ethics. For reporting to your diocese, see:

In addition, the Institute's Code of Conduct requires *all* members, staff and volunteers to report *all* behaviors that raise concerns or violate its Code of Conduct (*even if* the behavior or suspected behavior does not rise to the level of suspected or threatened child abuse or neglect under Wisconsin law, and *even if* the member, staff, or volunteer is not a Mandatory Reporter under Wisconsin law). This internal report should be made to the local superior or, if the superior himself is the subject of concern, to the Institute's provincial superior in Chicago. To make this internal report, use the form on the back of this page.

TO THE EXTENT ALLOWED BY LAW, all reporting will be kept in strict confidence, so as to protect the rights of the one who reports the concern, the potential victim, and the potential accused.
